Limited Eligibility - Early Enrollment is available only to first time members of NEA, excluding student memberships. If you have been a member of NEA in the past, this form will be processed not as an Early Enrollment application but rather as an application for the 2021-22 membership year with a membership start date not prior to September 1, 2021.

As a participant in the Local Association/Kansas National Education Association/National Education Association Early Enrollment Membership Incentive Plan, I am eligible to receive - prior to September 1, 2021, but in no event before April 1, 2021 - benefits under the NEA Educators Employment Liability (EEL) Program, as well as access to select NEA Member Benefits programs.

As a condition of eligibility for these benefits, I agree to pay the appropriate unified Active membership dues for the 2021-22 membership year in accordance with established payment procedures. Should I fail to do so, my eligibility to receive benefits under the NEA EEL Program shall immediately terminate. In addition, I shall become liable for the cost of any benefits that were provided to me under the NEA EEL Program prior to September 1, 2021.
